Background


The Ladywell area was prioritised as a location to consult for CPZ controls after being assessed against Lewisham Council's policy criteria for the consultation of CPZs. This was mainly due to the high number of requests for a CPZ originating from several Ladywell streets and two separate petitions amounting to 347 signatures. Other factors that have led to this consultation are the recently extended Ladywell CPZ (Zone T) and the new CPZ in Deptford South (Zone DS), which has unfortunately resulted in some displacement of parked vehicles into the area.

For more information on Lewisham Council's policy on CPZs, please refer to the 2014 policy which is available online.

Officers met with local Ward Councillors to determine the consultation boundary, and to discuss any issues that they were aware of prior to preliminary design and consultation.

On 17th May 2018, Lewisham Council consulted **2,870** properties via letter-drop within the Ladywell area, including eastern parts of Brockley, and two separate areas of Ladywell to the west and the south of the existing Zone T. Please see a map of the consultation area on the next page for reference. Each property was provided with a covering letter, paper questionnaire with freepost address, and an information booklet on CPZs. Although we provided a paper questionnaire, we encouraged responses via our online consultation portal.

This consultation was available for **21 days**, and we received valid responses from **869** properties. The majority (**70%**) of respondents used our online consultation portal to submit their views.







Conclusions

Ladywell West

Residents and businesses in the Ladywell West area generally responded positively to the introduction of a CPZ in their streets (64.6% support, 25.5% response rate), with a clear preference of restrictions operating Monday to Friday, with a majority opting for a two-hour restriction between the hours of 10am and 12pm. A CPZ operating at these times will:

- 1. Vastly reduce the number of commuters using the area to park throughout the week, allowing residents, businesses, and their visitors more opportunities to park closer to their property.
- 2. Offer unrestricted parking through most of the day, allowing visitors and services to residential properties to park for free outside the hours of the CPZ.
- 3. Still allow residents and visitors from Zone T to park in these streets whilst Zone T is operational and the new zone is not (I.e. 12pm-7pm)
- 4. Allow customers to businesses to park in any space for any length of time outside of the 2-hour restriction, up to 30 minutes for free in a designated short stay bay during the 2-hour zone, and pay by phone for up to two hours in any shared-use bay during the 2-hour zone.

Ladywell South

This defined consultation area did not receive a clear majority supporting the introduction of a CPZ in their streets, and there were very few roads with substantial support for a CPZ. Partial implementation of a CPZ on roads that supported the scheme would likely result in a large displacement of parking onto roads that did not support the scheme and roads outside the consultation area.

Brockley

This area to the west of Ladywell West (originally referred to as a section of Ladywell West) were generally strongly against any proposal to install CPZ controls in their streets. It has become evident that there is no current parking issue here, and there is little concern of displacement from the Ladywell area.

Recommendations

Due to the responses received as a result of this consultation, Lewisham Council recommend to:

- 1. **Progress** the 'Ladywell West' area as outlined in this document to statutory consultation with view to implementing a new 2-hour CPZ operative Monday to Friday between the hours of 10am and 12pm (midday).
- 2. Do not progress the 'Ladywell South' area to statutory consultation as outlined in this document. This defined consultation area does not meet Lewisham Council's policy criteria, and support for a CPZ is not focussed in one confined area. Partial implementation of a CPZ in this location is likely to result in substantial displacement of parked vehicles into neighbouring roads.
- 3. **Do not progress** the 'Brockley' area to statutory consultation as outlined in this document. This defined consultation area does not meet Lewisham Council's policy criteria, since there is very little support for a CPZ in this area.
