Controlled Parking Zone (CPZ) consultation in Ladywell – Have Your Say

Following requests we have had from local residents and businesses in your area about parking issues, Lewisham Council are consulting in your area to see if there is a need for a new CPZ.

A CPZ is an area where all on-street parking is controlled, and priority for parking spaces is given to local residents and businesses by means of parking permits. Parking bays are painted on the road to show where it is safe to park and all other kerb lengths are marked with yellow lines. This helps keep the street safe for both drivers and other road users allowing priority for parking to be given to disabled people, residents and their visitors and local businesses.

As a resident or business in the area you would need to purchase either a resident or business permit to park in the parking zone.

We will only introduce a new CPZ if more than 10% of households in the proposed area respond to this consultation, and over 50% of those that respond are in favour of a CPZ

To help you understand what is being proposed, the following documents are enclosed with this letter:

- 1. An Information Booklet which provides more detail on the proposals
- 2. A questionnaire for you to complete to have your say
- 3. A plan showing the area we are consulting (on the reverse of this letter)
